**CORRECTIVE  
SECOND AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF  
COVENANTS, CONDITIONS AND RESTRICTIONS FOR WATERSOUND ORIGINS**

THIS SECOND AMENDMENT is made as of the 26<sup>th</sup> day of April, 2019, by The Watersound Company, LLC, a Florida limited liability company (hereinafter referred to as "Declarant");

**W I T N E S S E T H**

WHEREAS, on June 29, 2006, that certain Community Charter for WaterSound was recorded in Official Records Book 2724, Page 3049 in the Official Records of Walton County, Florida (hereinafter, the "Records"); as amended by that certain First Amendment to the Community Charter for WaterSound, recorded in Official Records Book 2854, Page 490 of the Records; and by that certain Second Amendment to the Community Charter for WaterSound recorded in Official Records Book 2864, Page 4426 of the Records; and by that certain Third Amendment to the Community Charter for WaterSound recorded in Official Records Book 2869, Page 2760 of the Records; and by that certain Fourth Amendment to the Community Charter recorded in Official Records Book 2908, Page 4254 of the Records; and by that certain Fifth Amendment to the Community Charter recorded in Official Records Book 2927, Page 3407 of the Records; and by that certain Sixth Amendment to the Community Charter recorded in Official Records Book 2933, Page 4051 of the Records, and by that certain Seventh Amendment to the Community Charter recorded in Official Records Book 2933, Page 4056 of the Records; and as affected by that certain Assignment of Declarant's Rights recorded in Official Records Book 2985, Page 3436 of the Records; and as amended and restated by that certain Amended and Restated Declaration of Covenants, Conditions and Restrictions for Watersound Origins recorded in Official Records Book 2985, Page 3451 of the Records; and as amended by that certain Amendment to the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Watersound Origins recorded in Official Records Book 3002, Page 2631 of the Records; and as supplemented by that certain First Supplement to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Watersound Origins recorded in Official Records Book 3044, Page 3640 of the Records; and as supplemented by that certain Second Supplement to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Watersound Origins recorded in Official Records Book 3052, Page 1213 of the Records; and as supplemented by that certain Third Supplement to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Watersound Origins recorded in Official Records Book 3092, Page 4634 of the Records; and as supplemented by that certain Fourth Supplement to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Watersound Origins

recorded in Official Records Book 3103, Page 2663 of the Records (such instrument as at any time amended, restated and supplemented is hereinafter referred to as the "Declaration");

WHEREAS, pursuant to Section 7.3 of the Declaration, "[t]he Declarant reserves the right to amend the Declaration during the Development Period for the purpose of removing any portion of the Properties from the coverage of this Declaration. Such amendment shall not require the consent of any Person other than the Owner of the property to be withdrawn, if not the Declarant";

WHEREAS, Declarant desires to amend the Declaration to remove the property described on Exhibit "A" attached hereto and incorporated herein by this reference (the "Withdrawn Property") from the coverage of the Declaration;

WHEREAS, the Development Period has not expired or been terminated as of the date of this Amendment; and

WHEREAS, Declarant is the owner of the Withdrawn Property and no other consent is required under the Declaration.

NOW, THEREFORE, pursuant to the powers retained by Declarant under the Declaration, Declarant hereby amends the Declaration, as follows:

1. The above recitals are incorporated herein as true and correct and undefined terms shall have the same meaning as set forth in the Declaration.
2. Declarant hereby amends the Declaration and removes the Withdrawn Property from coverage of the Declaration. Exhibit "A" to the Declaration is hereby amended by deleting and withdrawing the Property described on Exhibit "A" to this Amendment.
3. Except as modified herein, the Declaration, and the terms, conditions and provisions therein, shall remain in full force and effect.
4. Invalidation of any provision of the Declaration, in whole or in part, or any application of a provision of the Declaration by judgment or court order shall in no way affect other provisions or applications. In the event there is a conflict of terms between this Amendment, the Governing Documents and the Declaration, the terms and provisions of this Amendment shall control.
