**NINTH AMENDMENT AND SUPPLEMENTAL DECLARATION
TO MASTER DECLARATION OF COVENANTS,
CONDITIONS AND RESTRICTIONS FOR AVENIR**

THIS NINTH AMENDMENT AND SUPPLEMENTAL DECLARATION TO MASTER DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR AVENIR ("Seventh Amendment") is made and executed this 1st day of October, 2025 by AVENIR DEVELOPMENT, LLC, a Florida limited liability company (the "Declarant").

RECITALS:

A. Declarant recorded that certain Master Declaration of Covenants, Conditions and Restrictions for Avenir on May 14, 2018 in Official Records Book 29849, Page 1173, as modified by that certain Partial Release of Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded on September 14, 2018 in Official Records Book 30121, Page 1982, and as amended by First Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded on September 26, 2018 in Official Records Book 30146, Page 475, Second Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded October 5, 2018 in Official Records Book 30168, Page 1968, Third Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded November 4, 2021 in Official Records Book 33026, Page 779, Fourth Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded December 9, 2022 in Official Records Book 34007, Page 763, Fifth Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded April 6, 2023 in Official Records Book 34224, Page 1662, Sixth Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded December 11, 2022 in Official Records Book 34716, Page 500, Seventh Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded January 19, 2024 in Official Records Book 34782, Page 1680, and Eighth Amendment to Master Declaration of Covenants, Conditions and Restrictions for Avenir recorded October 8, 2024 in Official Records Book 35316, Page 65, all of the Public Records of Palm Beach County, Florida (collectively, the "Declaration").

B. Pursuant to Section 18.1 of the Declaration, during the Class “B” Control Period (as defined in the Declaration) Declarant has the right to unilaterally amend the Declaration, and the Class “B” Control Period has not yet expired.

C. Declarant wishes to amend the Declaration to add the property described in Exhibit “A” attached hereto and made a part hereof (the “**Additional Property**”) and to subject the Additional Property to all terms and provisions of the Declaration.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Declarant does hereby amend the Declaration as follows:

1. **Recitals; Definitions.** The above recitals are true and correct and are incorporated herein by this reference. Unless otherwise defined, capitalized terms used above or herein shall have the meanings ascribed to them in the Declaration.

2. **Additional Property.** Declarant hereby subjects the Additional Property to all covenants, conditions, and restrictions contained in the Declaration, which shall hereafter constitute a covenant running with the land constituting the Additional Property. From and after the date of the recording of this Amendment, Avenir shall include both (i) the real property described in Exhibit “A” to the Declaration and all Amendments thereto, and (ii) the Additional Property.

3. **Ratification; Effective Date.** Except as modified or amended by this Ninth Amendment, the terms and provisions of the Declaration are hereby ratified and confirmed.

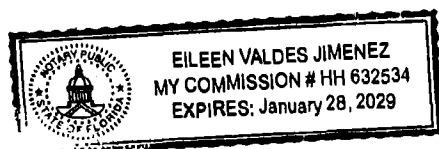
